The applications in the prescribed format are available on the website of Health and Family welfare Department ([www.karhfw.gov.in](http://www.karhfw.gov.in)) and Karnataka State Mental Health Authority ([www.ksmha.co.in](http://www.ksmha.co.in)) shall be submitted for the following categories under Sub- Section (1) of section 46 of the Act.

1	One mental health professional as required under clause (h) of subsection (1) of section 46 of Mental Health Care Act 2017 having a post-graduate degree (Ayurveda) in Mano Vigyan Avum Manas Roga or a post-graduate degree (Homoeopathy) in Psychiatry or a post-graduate degree (Unani) in Moalijat (Nafasiyatt) or a post-graduate degree (Siddha) in Sirappu Maruthuvam and at least fifteen years experience in the field,.

Eligibility Conditions:-

- 1.The applicant shall be an Indian National.
- 2.The applicant shall not be of the age exceeding sixty seven years.
- 3.Persons applying shall be registered with their respective State Mental Health Authorities. In Case the State Mental Health Authority has not being constituted in the State where such person is working, an undertaking to the effect that registration will be got done with the State Mental Health Authority within a month of its constitution.

Terms of office, allowances, of non-official members of State Mental Health Authority

Terms of office, allowances, etc, of non-official members of State Mental Health Authority will be as per the provisions of the Mental Health Care Act-2017

How to apply

Applications in the Prescribed format along with required certificates/documents shall be submitted through ordinary post/speed post/by hand to Chief Executive officer and Commissioner of Health and family welfare services, 3<sup>rd</sup> floor, Ananda Rao circle, Bengaluru-560 009. Last date for receipt of applications is 20<sup>th</sup> February 2020, till 5:00 PM.
